Leudelange Introduces Financial Support to Promote the Removal of Gravel Gardens

The Commune of Leudelange has adopted a local regulation establishing a subsidy scheme for individuals who own property within the municipal territory. The aim is to encourage the removal of gravel gardens and, more broadly, the unsealing of surfaces in favor of green spaces.

This initiative reflects a clear commitment to preserving local biodiversity and reducing the negative impact of impermeable surfaces on the environment. In collaboration with SICONA, the municipal council also aims to raise awareness among Leudelange residents about the nuisances and disadvantages of gravel gardens, while promoting ecological alternatives such as calcareous grass lawns.

Conditions for Granting Municipal Aid:

The financial aid is subject to the following conditions:

- It applies to the transformation of an existing gravel garden into a green area in front of an existing building, or the creation of a green area in front of a newly constructed building;
- · It can only be granted for properties located within the Municipality of Leudelange, upon request by the property owner(s);
- · For jointly owned properties or residences, the application must be submitted by the building management on behalf of the collective owners;
- The amount of aid depends on the size of the area to be transformed;
- No subsidy will be granted for the transformation of gravel gardens created after the regulation comes into effect;
- The aid can be granted only once every ten years per household, owner, or building.

Amounts of Municipal Aid:

- €250 for the creation of a new green area of at least 3 m² in front of a building;
- €500 for converting a gravel garden or a sealed surface of at least 3 m² into a green space;
- The amount is doubled when at least 50% of the existing surface in front of a building is redeveloped into green space.
