

SEAS Leudelange, february 2026

Dear parents,

From September 15, 2026, your child will attend the school of Leudelange and can benefit from the offer of the SEA – *Service d'éducation et d'accueil of Leudelange*. Attendance for new children is possible from 17.08.2026.

The transition from the nursery (SEA) to the Service of Education and Care for School-aged Children (SEAS) is an essential step in the educational journey of the child and the family. This period of change involves new points of reference, a new educational framework, as well as progressive adaptation to the rhythms and functioning related to the start of early schooling (précoce).

Within the framework of the values and pedagogical project of the Luxembourg Red Cross, the SEA ensures a progressive, safe, individualized transition that respects each child's rhythm.

This approach aims to guarantee:

- the emotional well-being and affective security of the child
- clear information and active involvement of parents
- close collaboration between the nursery educational teams and the SEAS Early Education – C1 team, ensuring continuity in education.

Transition process from SEAJ to SEAS Leudelange

Informative meetings take place in the form of individual visits for parents with their child to discover the SEAS (living spaces, playrooms, dining room), accompanied by the reference educator. The Early Education – C1 team presents the daily functioning of the SEAS, the reception procedures, as well as the pedagogical values and principles of the Luxembourg Red Cross.

A **picnic** is organized in the SEAS courtyard in collaboration with the childcare structures for young children (SEAJ). The children participate accompanied by their nursery (without parents), allowing them to discover their future environment in a familiar and reassuring setting.

The SEAS opens its doors during its usual operation to welcome parents and children for an **afternoon of workshops** in the various functional rooms. This moment allows the child to live a first concrete experience within the SEAS, to meet the Early Education – C1 team, and to create first social bonds.

The **first day of attendance** at the SEAS takes place in the presence of parents during the first hours. Separation is progressive and adapted to the pace of the child, with the attentive support of the reference educator and the Early Education – C1 team. During the informative meeting, we will share more detailed information on the progress of the first moments at SEAS.

A **welcome breakfast** is organized by the SEAS to encourage exchange between parents, the Early Education – C1 team, and other families in a friendly and informal setting.

- Complete the form “*Summer Holidays 17.08.2026 – 14.09.2026*”, **available** during the “informative meetings” (*registration deadline 01.07.2026*).
